

## RESOLUTION NO. 19418 (N.C.S.)

### ***A RESOLUTION OF THE SALINAS CITY COUNCIL APPROVING ONE YELLOW LOADING ZONE FOR THE SUPERIOR COURT OF CALIFORNIA AND ONE YELLOW LOADING ZONE FOR RANDY'S SNACK BAR AT THE MONTEREY COUNTY'S' GOVERNMENT CENTER***

**WHEREAS**, The city received a request from the Superior Court of California, requesting a yellow loading zone along the Monterey County Government Center's West Alisal Street frontage located at 240 Church Street; and

**WHEREAS**, City received a second request from Randy's Snack Bar located at 230 Church Street (corner of Church Street and Gabilan Street), requesting a yellow loading zone along his business' Church Street frontage; and

**WHEREAS**, on January 10, 2008, the Traffic and Transportation Commission voted unanimously (4-0) to recommend City Council adopt a resolution approving a YELLOW LOADING ZONE along the Monterey County Government Center's West Alisal Street frontage located at 240 Church Street; and an additional YELLOW LOADING ZONE for Randy's Snack Bar located at 230 Church Street along the south side of Gabilan Street, west of the Church Street and Gabilan Street intersection; and

**WHEREAS**, said Passenger Loading Zones (yellow curb) shall revert back to 2-hour parking for the Alisal Street Loading Zone and unrestricted parking for the Gabilan Street Loading zone when the Monterey County Government Center construction is completed;

**NOW; THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SALINAS:**

1. That the recitals set forth above are true and correct, and are incorporated herein by reference to Resolution No. 8337 (N.S.C.) adopted February 25, 1974, by adding YELLOW LOADING ZONES at the following location.
