A RESOLUTION OF THE SALINAS CITY COUNCIL ESTABLISHING 20 FEET OF "NO STOPPING" RED ZONES AT THE INTERSECTION OF VAN BUREN AVENUE AT FILLMORE STREET, 65 FEET OF "NO STOPPING" RED ZONES AT THE INTERSECTION OF ARTHUR STREET AT TRUMAN STREET AND 70 FEET OF "NO STOPPING" RED ZONES AT THE INTERSECTION OF RICO STREET AT VINCENT PLACE

WHEREAS, Staff received requests from residents to evaluate sight lines at the intersections of Van Buren Avenue at Fillmore Street, Arthur Street at Truman Street and Rico Street at Vincent Place; and

WHEREAS, Staff conducted an intersection sight distance analysis and is recommending 20 feet of "No Stopping" red zones at the intersection of Van Buren Avenue at Fillmore Street, 65 feet of "No Stopping" red zones at the intersection of Arthur Street at Truman Street and 70 feet of "No Stopping" red zones at the intersection of Rico Street at Vincent Place to provide sufficient intersection sight triangles; and

WHEREAS, on September 9, 2021, the Traffic and Transportation Commission voted (6-0) to recommend to City Council the approval of establishing a total of 20 feet of "No Stopping" red zones at the intersection of Van Buren Avenue at Fillmore Street, 65 feet of "No Stopping" red zones at the intersection of Arthur Street at Truman Street and 70 feet of "No Stopping" red zones at the intersection of Rico Street at Vincent Place; and

WHEREAS, the City of Salinas has determined that the implementing the parking restrictions is exempt from the California Environmental Quality Act (CEQA) Guidelines (Section 15301, Class 1). The project consists of the operation, repair, or minor alteration of public streets involving no expansion of use. There would be no significant effect on the environment.

NOW, THEREFORE, BE IT RESOLVED that the Salinas City Council hereby approves the establishment of 20 feet of "No Stopping" red zones at the intersection of Van Buren Avenue at Fillmore Street.

BE IT FURTHER RESOLVED, that the Salinas City Council hereby approves the establishment of 65 feet of "No Stopping" red zones at the intersection of Arthur Street at Truman Street.

BE IT FURTHER RESOLVED, that the Salinas City Council hereby approves the establishment of 70 feet of "No Stopping" red zones at the intersection of Rico Street at Vincent Place.
